When using ANAREZ®, iron oxide (rust) is converted to phosphates, which can be easily removed by rinsing or wiping. The surface is then ready for further editing and use. ANAREZ® is suitable for use wherever it is necessary to remove corrosion from the metal surface and further protect it with paint or otherwise modify it.

## USER MANUAL

---

Shake ANAREZ® thoroughly before use! The surface to be cut is first mechanically cleaned of dirt (eg with a wire brush, sandpaper). ANAREZ® is applied by brush or spray on the treated surface or you can immerse the objects to be cut into the solution. It is recommended to repeat the procedure several times for more corroded parts. This procedure speeds up the removal of corroded parts. ANAREZ® is left to act on the corroded surface until dry. Then wipe off the resulting powder and you can further modify the surface, for example with paint.

## WORK SAFETY

---

Flammable II. class! After finishing work, wash your hands with warm water and soap, then treat with cream.

## STORAGE

---

Do not store together with food. Out of reach of children. Protect from heat and direct sunlight and possible sources of ignition. Store in original containers with tightly closed closures. Storage temperature 5 to 30 ° C.

## DISPOSAL

Small amounts can be disposed of via sewer after dilution with more water and pH neutralization.
