DOSAGE AND DILUTION

NOVALON® 9000 is to be diluted with water according to the degree of contamination before application

For extreme applications for strong contamination	1:1, or do not dilute at all.
Common contamination	1:10 to 1:20
For frequency cleansing and slight contamination	1:20 to 1:30
For ultrasound cleansing	1:5 to 1:20

USER MANUAL

Method of application: First, all loose dirt should be removed from the surface. Spray sufficient quantity of the detergent onto the contaminated surface and let take effect (1 to 60 minutes). Use a brush or a sponge and rinse the surface off with a sufficient quantity of water. The response of delicate materials (leather, textiles) should be pre-tested.
