This property can be used to diagnose malfunctions in electrical installations, e.g. temperature sensors, bimetallic switches, etc. Rapid cooling also affects the thermal expansion of materials. Due to this, AIRSOL® - subcooling spray finds application in assembly and disassembly of parts, storage of ball bearings of shafts and bushings. It is intended for the repair and maintenance of machines and equipment, at the same time it can be used to perfectly remove stuck chewing gum residues.
