DOSAGE AND DILUTION

One dose is 200 ml to 500 ml of DRAVEX® BIO according to the type of operation.

Week 1	to be applied twice a day	200 to 500ml
Week 2	to be applied once a day	200 to 500ml
From Week 3 on	to be applied once to twice a week	200 to 500ml – it is a maintenance dose which guarantees passability of the system.

USER MANUAL

Apply the dose of DRAVEX® BIO measured out directly to any sink, drain, or basin so that the product might get into the whole system. Always pour about 0.5 l of lukewarm water over the dose applied so that the active substances might penetrate the system. Do not use hot water!
