SECTION 4: First aid measures

4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

If inhaled

Inhalation of the sprayed mixture or mist can cause severe irritation of the respiratory tract, coughing, burning of the respiratory system.

4.3. Indication of any immediate medical attention and special treatment needed

SECTION 5: Firefighting measures

8.2. Exposure controls
